1. Use revised pricing sheet named CA Spreadsheet AD1 posted to website.
2. Item #3, page 8 of specifications has been deleted.
3. Item #7, page 8 of specifications has been changed to:
Bid must be fixed for all non-commodity products and cost plus on commodity items i.e., produce, fresh meats, fish, poultry for the duration of the bid. Your bid should reflect the price for commodity items for the week of October 17, 2011 thru October 21, 2011. The bid prices contained in your initial bid submission for commodity items are considered "firm" for one (1) week. The selling prices quoted should be bottom line vendor cost plus fixed %. The fixed % fee shall remain the same throughout the bid period. Include your fixed % on space listed below.

4. Indicate all commodity items subject to pricing changes on Column M on pricing spreadsheet.
5. Leave unit cost blank for items you cannot provide.
6. Indicate different size /packaging in column F on pricing spreadsheet.

7. All fish must be HAND PROCESSED ONLY or it will be rejected. No machine processed product will be accepted.
8. Item #19 on pricing spreadsheet-Select Oysters in the gallon 7/1 East Coast Product ONLY.
9. Item #22 on pricing spreadsheet - all natural scallop, not dry packed, 10/20 fresh scallop only.
10. Item #24 on pricing spreadsheet - IQF All Natural Dry Packed 10/20 Sea Scallop.
11. Item #27 Snow Crab Clusters 8-10oz Canadian ONLY.
12. Item #29 on pricing spreadsheet -Crayfish meat, Imported ONLY. NO DOMESTIC ALLOWED.
13. Item #30- on pricing spreadsheet Town Dock whole squid 6-8 inches size DOMESTIC ONLY.
14. Item #31 on pricing spreadsheet -Town Dock squid 5-8 inches, DOMESTIC ONLY, T&T.
15. Item #33 on pricing spreadsheet whole octopus 1-2 lb ONLY.
16. Item #35 on pricing spreadsheet -Live Lobsters HARD SHELL ONLY, NOT FARMED.
17. Item #40 on pricing spreadsheet 7-9oz FRESH hand cut ONLY Catfish fillet.
18. Item #44 on pricing spreadsheet- frog legs 6-8 count.
19. Item #49 on pricing spreadsheet - Tuna loin 2+ GRADE ONLY
20. #54 on pricing spreadsheet- Halibut FRESH ONLY filets.
21. Item #55 through item# 60 - ONLY FRESH HAND PROCESSED FILLETS.
22. #234 on pricing spreadsheet -Whole Quail, provide price for both fresh and frozen product. Line item #234A has been added for frozen.
