It is acknowledged and understood that I am responsible for the costs of any and all medical and health services I may require as a result of such participation. Further, I hereby agree to indemnify and at Joliet Junior College's request, defend and save harmless, Joliet Junior College,

its Trustees, officers, employees, volunteers, agents, servants and assigns from and against any loss, damages, costs, claims or expenses arising out of any actual or claim of death or injury to any person or actual or claim of damage to property, whether owned by me, Joliet Junior College, its Releasees or third parties, including loss of use, that actually or allegedly results from my conduct, my act or omission, relating to my participation in said events, trips and/or activities.

If I choose to transport other persons or students in my personal vehicle to this activity, I certify that I have adequate insurance and I agree that I shall indemnify Joliet Junior College and its Releasees against any claim brought against them by my passengers. I shall also provide to Joliet Junior College a copy of my motor vehicle liability policy. Further, I will not possess or use alcohol or unlawful substances while participating in this activity.
