PROJECT NAME: Replace H-Building Exterior Stairs

This Addendum forms a part of the Bidding and Contract Documents and modifies the original bidding document as posted on the JJC website. Acknowledge receipt of this addendum in the space provided on the Bid Form. FAILURE TO DO SO MAY SUBJECT BIDDER TO DISQUALIFICATION.

Contractor Questions Submitted:

Q: Are we to paint the roof of the stairs and the galvanized metal?

A: No, all standing seam panels, flashing and trim shall be galvanized per mfgr./specs.

Additional Items:

Refer to the revised drawings as part of this addendum.

Refer to the revised bid form as part of this addendum that includes pricing line items for Alternate #1 and Alternate #2.

Bidder is to include a \$12,500 allowance within their base bid for miscellaneous unforeseen conditions. This allowance is to be expended only at the direction of JJC. The bidder is to include any necessary overhead and profit to carry this allowance. Should JJC authorize any charges against this allowances it will be for raw material and labor costs (no overhead and profit).

Contractor is to provide and install a silt fence around the perimeter of their work near the lake at the two new towers (not needed at alternate bids). Perimeter size of this silt fence is to be determined by contractor. Contractor is to ensure debris from excavation and construction does not enter the lake.

Contractor is to provide construction fencing (can be orange plastic fencing) around the perimeter of their work at the two new towers (not needed at alternate bids) to prevent general public access to their work sites. Contractor to ensure sites are secured at the end of each work day.

It was mentioned in the prebid meeting that the fire lane behind "K" building will be paved in the near future. JJC has delayed paving of this fire lane until Fall of this year (September/October). May be sooner if major construction on the towers is complete and can be coordinated with awarded contractor.

Addendum #1 removes requirements of AISC certification. Although certification is not required, AISC standards must still be followed.
