Questions Submitted:

- 1. Page 20 of the bid for form for Concrete asks for a price for Under Slab Insulation. It is not show on the drawings where this is required. Please advise.
 - There is insulation at the stoops (See S1.02 detail 3) and there will be 2" thick rigid board extending 24" vertical on the interior face of all perimeter foundation walls.
- What size wire mesh is required in the topping or are fibers acceptable?
 Provide 6x6 W2.1xW2.1 WWR in the slab on steel deck.
- 3. Concrete Slabs what areas will be poured in each of the following months? We need to know what to protect. November December February June

 In November and December the first floor slabs will need to be poured. In February a portion of the second floor slabs (50%) and the balance of all remaining slabs in June of 2016.
- 4. You are requesting a unit price for blankets Are they electrical or thermal blankets. *Thermal blankets should be required for pours to protect from frost.*

Clarifications:

- 1. Concrete bid package R-03B: Excavation, Grading, Asphalt and Site Utilities Work R-02B: Eliminate the Asphalt Paving and concrete curb work from the R-02B Excavation, Grading, Asphalt and Site Utilities Work bid. This will be bid separately at a later date.
