#### **Project:**

Please provide a lump sum bid to transform a walk in refrigerator unit into a dry curing/aging salami walk in unit where moisture, temperature and humidity are all regulated and adjustable.

Pricing shall include Refrigeration-Commercial Design and Installation, Complete HVAC design and installation-including material and equipment. All engineering based on customer-provided specifications and requirements to be able to control at 45-80F and 50-80% RH with no more than 500 lbs. of product.

#### **Contractor to provide:**

Must provide one reference of customer with similar temperature and humidity controlled project

Refrigeration-Commercial Design and Installation

Install Trenton TEHA Series Indoor condensing unit mounted above cooler: 407c, 208-230 1ph MCA 6.3a, MOP 15a

Install Trenton TLV Series Low Velocity Evaporator: R407c, 208-230V 1ph, MVA 18.8a, MOP 25a

- Must include Stainless construction with coated coils to protect against corrosion from salt
- Must include heaters installed to add heat when dehumidification is required, but cooling setpoint has been satisfied

Must include Ke2Therm Controlled Environment Temperature and Humidity Controller Kit #20897

Must include a controlled misting device installed in evaporator air stream to add humidity to the air when required.

Make all final connections from hot water supply to unit (hot water supply provided by owner)

Installation of New Refrigeration Equipment or Relocation/Rebuilding of Existing Refrigeration Equipment as required

### **Joliet Junior College will provide:**

- Hot water supply to the unit at .5 gpm.
- Electrical Service (service only) at Evaporator: 208-230v 1ph, MCA 1.1a, MOP 12a
- Electrical Service (service only) at Condensing Unit: 208-230v 1ph, MCA 6.3a, MOP 15a
- Evaporator drain

## Existing Walk-In Internal Dimensions: 12'4" deep x 8'5" tall x 5'4" wide

### **Additional Information:**

The existing unit does not have its own compressor. It is currently cooled through a hole in the wall with a small fan that draws cold air from the adjacent walk-in unit. The hole should be capped to be in compliance with health department guidelines and no longer used when the project is completed with its own contained system.

No substitutions will be accepted.
